**RESOLUTION NO. 6952**

**REAPPOINTING EIGHTY-ONE URBAN RENEWAL ADVISORY COMMITTEE  
MEMBERS TO TERMS ENDING SEPTEMBER 30, 2013**

**WHEREAS**, on September 14, 2005, the Board of the Portland Development Commission (“Board”) adopted a formal policy (“Policy”) regarding the operation of Urban Renewal Advisory Committees (“URAC”);




