**WHEREAS**, the PDC Board of Commissioners ("Board") recognizes and values the contribution that existing community groups and individuals provide in developing and implementing urban renewal plans;

**WHEREAS**, an Urban Renewal Advisory Committee ("URAC") can provide valuable feedback to the Board and project staff on short and long term implementation plans and budgets, and assistance to staff in identifying and involving other community stakeholders in urban renewal projects;

**WHEREAS**, on June 14, 2006, the Board established the Central Eastside ("CES") URAC (Resolution 6367); and

**WHEREAS**, participation of citywide and creative industry representation on the CES URAC continues to be an interest of the Board and the CES URAC.

**NOW, THEREFORE, BE IT RESOLVED** that a regular at-large member position representing citywide interests shall be created for the CES URAC;

**BE IT FURTHER RESOLVED** that Eric Shoemaker is hereby appointed to the CES URAC as a regular at-large member position representing citywide interests for a term beginning March 25, 2009 and ending June 30, 2012;

**BE IT FURTHER RESOLVED** that a regular at-large member position representing creative industry interests shall be created for the CES URAC;

**BE IT FURTHER RESOLVED** that Dardinelle Troen is hereby appointed to the CES URAC as a regular at-large member representing creative industry interests for a term beginning on March 25, 2009 and ending on June 30, 2012; and

**BE IT FURTHER RESOLVED** that this resolution shall become effective immediately upon its adoption.
