
**WHEREAS**, on June 14, 2006, the Board established the Oregon Convention Center Urban Renewal Advisory Committee (Resolution 6367); and

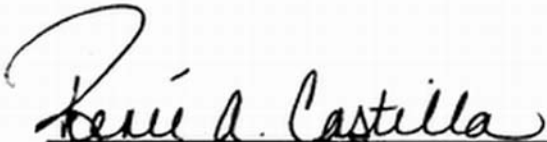
